

## TERMS & CONDITIONS

### Win Your Wedding at Etymon Competition

#### 1. Promoter

1.1 The promoter is Etymon Etymon Projects Pty Ltd ABN 88 646 970 089 of 264 George St, Sydney Australia 2000 ("Etymon", "we", "us", "our").

#### 2. Eligibility

2.1 Entry is open to Australian residents aged 18 years or over who are planning to marry.

2.2 Employees of Etymon, their immediate families, and associated agencies are ineligible to enter.

2.3 By entering, participants confirm they have authority to provide the contact details submitted.

2.4 Only one entry per couple is permitted across all entry methods.

#### 3. Entry Period and Methods

3.1 Entries open on February 9 2026 and close at March 30 2026 ("Entry Period").

3.2 Entry is available via two methods:

(a) Completing the entry form at the Etymon booth during the wedding expo held at Randwick Racecourse during the Entry Period; OR

(b) Completing the online entry form via Etymon's social media channels or website at [etymon.com.au](http://etymon.com.au) during the Entry Period.

3.3 Entries submitted outside the Entry Period will not be accepted.

3.4 Only one entry per couple is permitted. Multiple entries by the same couple across different entry methods will be deemed duplicate entries and only the first valid entry received will be included in the draw.

3.5 Entry implies acceptance of these terms and conditions.

#### 4. The Prize

4.1 The prize consists of a wedding venue package at Soluna North Sydney valued at \$15,000 (including GST) comprising:

(a) Exclusive venue hire of Soluna North Sydney for 5 hours;

(b) Standard two-course menu (valued at \$60 per person);

(c) Standard three-hour beverage package (valued at \$85 per person);

(d) Serving staffing costs; and

(e) Service for up to 80 guests.

4.2 Available dates:

(a) June–August 2026, excluding Sundays; OR

(b) September–October 2026, Monday–Thursday only.

4.3 Blackout dates: All public holidays and associated long weekends are excluded.

4.4 The prize does not include:

(a) Styling, decorations, florals, or additional furniture hire;

(b) Removalist services if required;

- (c) Photography or videography services;
- (d) Wedding cake or dessert beyond the standard menu;
- (e) Extended beverage packages beyond three hours;
- (f) Menu upgrades beyond the standard two-course offering;
- (g) Additional guests beyond 80 persons;
- (h) Entertainment, coordination services, or celebrant services;
- (i) Service charge for staff members (\$1,500);
- (j) Transport or accommodation; or
- (k) Any other items not expressly listed in clause 4.1.

4.5 The winner is responsible for paying the service charge of \$1,500 for staff members in addition to receiving the prize package.

4.6 The winner may upgrade menu options, extend beverage packages, add additional guests, or purchase additional services at their own expense in accordance with Etymon's standard pricing.

4.7 The prize is non-transferable, non-refundable, and cannot be exchanged for cash or other goods or services.

4.8 The prize must be taken as offered and cannot be varied.

4.9 Etymon reserves the right to substitute the prize for another of equal or greater value if circumstances beyond its control make this necessary.

## **5. Winner Selection and Notification**

5.1 The winner will be selected at 264 George St, Sydney Australia on 30 March 2026 at 12pm ("Draw Date").

5.2 All valid entries received via both entry methods will be included in the single draw.

5.3 Unlimited reserve winners may be drawn in case the first winner is invalid or cannot be contacted.

5.4 The winner will be notified by telephone and email within seven days of the Draw Date using the contact details provided at entry.

5.5 The winner's first name and partner name will be published on Etymon's social media channels and website within 28 days of the Draw Date.

5.6 If the winner cannot be contacted within 14 days of the Draw Date using the contact details provided, or does not claim the prize within 28 days of initial notification, or does not satisfy the validation requirements in clause 6, the prize will be forfeited and awarded to a reserve winner.

## **6. Validation and Verification**

6.1 Etymon reserves the right to verify the validity of entries and to disqualify any entrant who:

- (a) Tampers with the entry process;
- (b) Submits an entry that is incomplete, illegible, or contains incorrect information;
- (c) Submits duplicate entries;
- (d) Fails to provide proof of identity or eligibility when requested; or
- (e) Engages in conduct that is fraudulent, misleading, or generally damaging to Etymon's reputation.

6.2 The winner may be required to provide proof of identity and eligibility to Etymon's satisfaction before the prize is awarded.

## **7. Prize Conditions**

7.1 The winner must book their wedding date within 90 days of being notified of their win.

7.2 The wedding must take place between 1 June 2026 and 31 October 2026, subject to the date restrictions in clause 4.2.

7.3 Booking is subject to venue availability at the time of booking.

7.4 The winner must enter into Etymon's standard venue hire agreement and comply with all terms, conditions, policies, and procedures contained therein.

7.5 The winner is responsible for all costs associated with:

- (a) The service charge for staff members (\$1,500);
- (b) Upgrading menu selections;
- (c) Extending beverage packages beyond three hours;
- (d) Adding guests beyond 80 persons;
- (e) Styling, decorations, florals, and additional furniture;
- (f) Photography, videography, entertainment, and celebrant services;
- (g) Wedding cake and coordination services; and
- (h) Any additional services or items not included in clause 4.1.

7.6 All additional costs must be paid in accordance with Etymon's standard payment terms.

7.7 Final guest numbers must be confirmed at least 14 days prior to the wedding date.

7.8 The winner must comply with all applicable laws, venue capacity limits, and responsible service of alcohol requirements.

7.9 Etymon retains full and exclusive rights to all photography, videography, audio recordings, and other media content captured at the wedding event ("Content"). The winner:

- (a) Agrees to hiring professional photographer & videographer for the event
- (b) Consents to Etymon using, reproducing, adapting, publishing, and distributing the Content for marketing, promotional, and commercial purposes in any media in perpetuity without additional compensation;
- (b) Grants Etymon an irrevocable, perpetual, worldwide, royalty-free licence to use the Content;
- (c) Consents to the use of their names, images, and likenesses in connection with the Content; and
- (d) Waives any moral rights in the Content to the extent permitted by law.

7.10 If the winner cancels or postpones their wedding for any reason, the prize is forfeited and no cash or alternative compensation will be provided.

7.11 The winner is responsible for obtaining all necessary consents from guests appearing in any Content captured at the event.

7.12 If the winner fails to meet their financial obligations under clause 7.5, including payment of the \$1,500 service charge, or fails to comply with the venue hire agreement, the prize will be forfeited and no refund or alternative compensation will be provided.

## **8. Liability and Exclusions**

8.1 Etymon accepts no responsibility for:

- (a) Late, lost, misdirected, incomplete, or illegible entries;
- (b) Any technical difficulties, malfunctions, interruptions to service, or internet connectivity issues that may prevent entry;
- (c) Any injury, loss, or damage suffered in connection with the prize or participation in this competition, except as required by law; or
- (d) Any variation in prize value.

8.2 To the extent permitted by law, Etymon and its associated agencies exclude all liability (including negligence) for any personal injury or property damage arising in connection with this competition or the prize.

8.3 Nothing in these terms and conditions excludes, restricts, or modifies any consumer rights under the Competition and Consumer Act 2010 (Cth) or any other applicable law that cannot be excluded, restricted, or modified by agreement.

8.4 Subject to clause 8.3, the winner participates in this competition and accepts the prize at their own risk.
